ORDER:

The Registrar of Co-operative Societies, Puducherry has submitted a proposal for the sanction of Rs.86.54 Lakhs to Consumer Co-operatives as Subsidy for the year 2012-13.

2. Accordingly, sanction of the Lieutenant Governor is hereby accorded for incurring of an expenditure not exceeding Rs.86.54 Lakhs (Rupees eighty six lakhs and fifty four thousand only) as Subsidy in Puducherry, Karaikal and Mahe Regions as detailed below and the society-wise details are enclosed in the Annexure I.

3. The release of grant-in-aid is subject to the following conditions:

- The society shall get its accounts audited by Chartered Accountants/Departmental Auditors, as the case may be and the audited statements of financial accounts shall be submitted to Government before closure of the next financial year as per GFR 212.
- The accounts of the society shall be open to inspection by the sanctioning authority and audit by the Directorate of Accounts & Treasuries and Accountant General.
- The society shall maintain subsidy accounts of the Government as required under GFR 210.

- d. A certificate of actual utilization shall be furnished in accordance with the provisions of the Financial Rules, 1953.
 - e. Annual report of the society shall be submitted to the Government.
 - f. The annual accounts of the grant receiving society should be completed within one month of the end of the financial year.
