ORDER

Sanction of the Lieutenant Governor is hereby accorded for the release of Grants-in-aid not exceeding Rs.9,30,00,000/- (Rupees Nine crores and thirty lakhs only) towards financial assistance Under Handloom Development Scheme for the year 2015-2016 as, Grants-in-aid to **PONTEX**, **PONFAB**, and 12 Primary Weavers' Cooperative Societies in Puducherry and Mahe Regions as detailed in the annexure for the following schemes.

- Market Development Assistance
- Thrift Fund
- Production incentive
- Interest Subsidy on Working Capital
- Hank Yarn Subsidy
- Publicity Propaganda
- Assistance for participation in exhibition
- Participation in All India Handloom fortnight celebration
- Improvements to Office-cum-godown

2. This grant is for recurring / non-recurring expenditure and is subject to the following conditions.

- a) The grant shall be utilized in a time bound manner
- b) The unspent balance of the previous grant has been taken into account
- c) The Society shall get its accounts audited from Chartered Accountants/ Departmental Auditors.
- d) The accounts of the society shall be open to inspection by the sanctioning Authority and audit by the Directorate of Accounts and Accountant General.
- e) The society shall maintain subsidiary accounts of the Government grants as required under GFR 210.
- f) Annual Reports of the society shall be submitted to the Government
- g) The annual accounts of the grant receiving society should be completed within six months of the end of the financial year

3. Certified that the pattern of assistance is in accordance with Plan Scheme duly approved by the Planning and Research Department, Puducherry.

4. The Director of Accounts and Treasuries may admit the bill after obtaining the utilization certificate for the grants released during the year 2014-2015.
