- b. The accounts of the society shall be open to inspection by the sanctioning authority and audit by the Directorate of Accounts & Treasuries and Accountant General.
- c. The society shall maintain subsidiary accounts of the Government as required under GFR 210.
- d. A certificate of actual utilization shall be furnished in accordance with G.F. R. 212 (1) in Form GFR 19-A.
- e. Annual report of the society shall be submitted to the Government.
- f. Interest accrued from Bank Accounts should be remitted into Govt. Account under the Head of account "0049 - Interest Receipts -04- Interest Receipts of State/UT Governments - 110 - Interest realized on Investment of cash balances" at the end of the financial year concerned.
