ORDER:

Sanction of the Lieutenant Governor is accorded for release of Rs.1,83,00,000/-(Rupees one crore and eighty three lakhs only) towards Grant-in-aid to the Primary Co-operative Housing Societies through the Pondicherry State Co-operative Housing Federation as detailed here under:

1.	Primary Co-operative Housing Societies through Pondicherry State Co-operative Housing Federation - 3% Interest rebate	Rs.1,83,00,000/-

2. The grant is for recurring /non-recurring expenditure and is subject to the following:-

- a) The grants shall be utilized in a time bound manner
- b) The unspent balance of the previous grant has been taken into account.
- c) The society shall get its accounts audited by chartered accounts/ Departmental auditors.
- d) The accounts of the society shall be opened for inspection by the sanctioning authority and audit by the Directorate of Accounts and Accountant General.
- e) The society shall maintain subsidiary accounts of the Government grants as required under G.F.R 210.
- f) The interest rebate is in accordance with the rules/guidelines issued vide Government Order 2st cited.
- g) A certificate of actual utilization shall be furnished in accordance with G.F.R. 212 (1).
- h) Annual Report of the society shall be submitted to the Government.
- i) The annual accounts of the grant receiving society/institution should be completed within one month of the end of the financial year.

3. Certified that the pattern of assistance is in accordance with plan scheme duly approved by the Planning and Research Department.

4. The expenditure is debitable to the Head of Account "2216 -Housing -02-Urban Housing - 02/104 - Housing Co-operatives -02/104 (01) Assistance to Housing Co-operatives 02/104 (01) (01) - Puducherry Region (31) Grant-in-aid (PLAN)" in the budget of the current financial year
