The Registrar of Co-operative Societies, Puducherry has submitted a proposal for Rs. 6.66 lakhs towards sanction of financial assistance to Agricultural Credit Co-operatives for the year 2013-14 under the ongoing scheme "Assistance to Agricultural Credit Co-operatives".

2. Accordingly, the sanction of the Lieutenant Governor is hereby accorded for incurring of an expenditure not exceeding Rs.6.66 lakhs (Rupees Six lakhs and Sixty Six Thousand Only) to the Primary Agricultural Co-operative Credit Societies/Village Co-operative Agricultural Credit Societies/Farmers Service Co-operative Societies in Puducherry and Karaikal regions towards release of grant-in-aid for reimbursement of Tractor Hire Charges to the Scheduled Caste farmer members under Special Component Plan as detailed in the Annexure.

3. The grant is for recurring/non-recurring expenditure and is subject to the following conditions :

- (i) The unspent balance of the previous grant shall be taken into account.
- (ii) The Society/Institution shall get its accounts audited by Chartered Accountant and the audited statement of financial Accounts of the society shall be submitted to Government within one year.
- (iii) The accounts of the society/institution shall be open to inspection by the sanctioning authority and audit by the Directorate of Accounts and Treasuries/Accountant General.
- (iv) The society/institution shall maintain subsidiary accounts of the Government grants as required under G.F.R 210.
- (v) A certificate of actual utilization shall be furnished in accordance with G.F.R.212 (1) in the format GFR 19-A.
- (vi) Annual Report of the society/institution shall be submitted to the Government.
- (vii) The annual accounts of the grant receiving society/institution should be completed within one month of the end of the financial year.

4. Certified that the pattern of assistance is in accordance with plan scheme duly approved by the Planning commission.
5. The Director of Accounts and Treasuries may admit the bill only after obtaining the utilization certificate for the share capital/grant-in-aid released during the year 2011-12.
6. The expenditure is debitable to the following head of account in the budget of the current financial year.
