Co-operation – Appointment of nominee in Agricultural Credit Societies/ Farmers Service Co-operative Societies – Approval.

READ: Letter No.9/2/5/RCS/C2/86/561 dated 24.10.1989 from the Registrar of Co-operative Societies, Pondicherry.

ORDER:

The Committee of Estimates (1982-83) in their 32nd Report recommended inter alia that subject to the provisions containing in by-laws of societies, action may be taken to appoint nominees of Government and that of financing banks in each of the village co-operative agricultural credit societies. The Committee on Estimates (1987-88) has insisted for such an action.

In accordance with the above said recommendation the Department of Co-operation has carried out pre-requisite of amending the by-laws of village co-operative agricultural credit societies, farmers service co-operative societies so as to provide for such nomination. The Registrar of Co-operative Societies has requested the Government for approval of proposal of Government nominees to the said societies which is in conformity with provisions contained under Section 32 of the Pondicherry Co-operative Societies Act, 1972.

After careful consideration, Government approved the appointment of nominee from Government to the village co-operative agricultural credit societies/farmers service co-operative societies in the three regions Pondicherry and Karaikal and Yanam as shown below:

**DIRECTIONS OF THE REGISTRAR OF CO-OPERATIVE SOCIETIES ISSUED
UNDER SECTION 81(1) OF THE PONDICHERRY CO-OPERATIVE
SOCIETIES ACT, 1972**

Sub: Prohibition of use of the word “Bank” by Primary Agricultural
Co-operative Banks as part of their name – Directions under Section
81(1) of the Pondicherry Co-operative Societies Act, 1972 – Issued

Read : This office Circular No.5/1/1/14/RCS/Credit/C3/96/263 dated
15.10.1996.

WHEREAS the Reserve Bank of India is repeatedly insisting that the primary agricultural co-operative banks, which are using the word “Bank” as a part of their name, should not use the word “Bank” in their title or nomenclature since the deposits accepted by such primary agricultural co-operative banks are not covered under the insurance of the “Deposit Insurance and Credit-Guarantee Corporation”;

AND WHEREAS, in view of the above, the primary agricultural co-operative banks, functioning in this Union territory of Pondicherry, were instructed, vide the reference cited, to take necessary steps to amend their bye-laws so as to delete the word “Bank” from the title;

AND WHEREAS, it is noticed that the primary agricultural co-operative banks have not taken steps to amend their bye-laws for deleting the word “Bank” from the title;

AND WHEREAS, in view of the above, the undersigned felt it necessary to issue directions, under Section 81(1) of the Pondicherry Co-operative Societies Act, 1972, to the Primary Agricultural Co-operative Banks to arrange to delete the word “Bank” from the names;

NOW, THEREFORE, in view of the reasons stated above and in exercise of the powers conferred on him, by sub-section (1) of Section 81 of the Pondicherry Co-operative Societies Act, 1972, the undersigned hereby directs the managements of the primary agricultural co-operative banks, functioning in this Union territory of Pondicherry, to amend their bye-laws, for deleting the word “Bank” from their names, by way of passing a resolution in their general body and to send the amendment to this office, immediately, for registration.

The receipt of this direction should be acknowledged. Action taken in this regard should be intimated to the undersigned, within 15 days from the date of receipt of this direction.

WHEREAS, the Government of Pondicherry is providing financial assistance, in the form of loans and subsidies to the agricultural co-operative societies, such as, Primary Agricultural Co-operative Societies (PACS), Primary Agricultural Co-operative Banks (PACB), Village Co-operative Agricultural Credit Societies (VCACS), Farmers' Service Co-operative Societies (FSCS), for the purchase of agricultural machineries / tools;

AND WHEREAS, the said societies are letting their tractors to their members, on hire, for the purpose of agricultural and allied activities;

AND WHEREAS, it is brought to the notice that, hire charge levied by the said societies, for similar activities, are not uniform;

AND WHEREAS, in order to bring uniformity in the levy of tractor hire charge, it is felt necessary to prescribe a standard rate of tractor hire charges, to be collected by the said societies;

NOW, THEREFORE, in exercise of the powers conferred on me by sub-section (1) of Section 81 of the Pondicherry Co-operative Societies Act, 1972 and for the purpose of securing proper implementation of co-operative production and to secure proper management of the business of the said societies and in the better interest of the members of the said societies, I hereby prescribe the rates as stated in following table for the levy of tractor hire charge:

In respect of other activities, tractor line charges shall be levied at the rate of Rs.1,000/- per day.

The tractor hire charges, prescribed above, shall come into force with immediate effect.

All the Primary Agricultural Co-operative Societies (PACCS), Primary Agricultural Co-operative Banks (PACB), Village Co-operative Agricultural Credit Societies (VCACS) and Farmers' Service Co-operative Societies (FSCS), functioning in the Union territory of Pondicherry, are directed to strictly comply with the tariff prescribed above.

ORDER:

WHEREAS during the last few years, the farmers have been continuously facing hardship due to natural calamities viz., drought, flood, Tsunami, etc. resulting in non repayment of loans availed by them from the agricultural co-operative credit institutions for raising crops and also for allied agricultural activities. In order to relieve the farmers from their debts and to make them eligible to avail fresh loans and to enable them to continue with their agricultural and allied activities without any hurdles, the Hon'ble Chief Minister, Puducherry had in the budget speech 2006-07 announced that the principal, interest and penal interest outstanding as on 31.3.2006 to the tune of Rs.27.45 crores on the agricultural loans availed by the farmers of the Union territory of Puducherry for agriculture and its allied activities from the agricultural co-operative credit institution will be waived;

AND WHEREAS in the year 2008, the Government of India had announced Debt Waiver and Debt Relief Scheme 2008 for waiver of agricultural loans availed by the farmers from various financial institutions including co-operative banks/societies, in which some of the agricultural loans outstanding as on 31.3.2006 proposed for waiver in the agricultural loans waiver scheme announced in the budget speech 2006-07 have not been covered. Therefore, for the purpose of extending relief to the farmers it is felt necessary to cover the said loans under the debt waiver scheme proposed in pursuance of the announcement made to this effect in the budget speech 2006-07;

AND WHEREAS the aforesaid proposal for such waiver has been considered and duly approved by the Government;

NOW THEREFORE, the Lieutenant Governor, Puducherry is pleased to direct that all the outstanding loans issued for agricultural and its allied purposes as on 31.3.2006 left unwaived under the Government of India Debt Waiver and Debt Relief Scheme 2008 along with interest, penal interest and other charges if any payable by the farmers shall be waived by all co-operative credit institutions viz. the Pondicherry State Co-operative Bank, the primary agricultural co-operative banks, the primary agricultural co-operative credit societies, the village co-operative agricultural credit societies, the farmers service co-operative societies and the Pondicherry Co-operative Central Land Development Bank

2. The Pondicherry State Co-operative Bank, primary agricultural co-operative banks, primary agricultural co-operative credit societies, village co-operative agricultural credit societies, farmers service co-operative societies and Pondicherry Co-operative Central Land Development Bank concerned are also hereby directed to implement this order in accordance with the operational guidelines enclosed in the Annexure.

ANNEXURE

Agricultural loans Waiver Scheme 2008-09 - Operational Guidelines for Waiver of Agricultural loans outstanding as on 31.03.2006 availed by the members of the Pondicherry State Co-operative Bank, Primary Agricultural Co-operative Banks, Primary Agricultural Co-operative Credit Societies, Village Co-operative Agricultural Credit Societies, Farmers Service Co-operative Societies and Pondicherry Co-operative Central Land Development Bank for agricultural and allied activities from their respective Banks/ Credit Societies

I. SCOPE:

This scheme will cover all agricultural and allied activities loans availed by the members of the Pondicherry State Co-operative Bank, primary agriculture co-operative banks/ primary agriculture co-operative credit societies/ village co-operative agriculture credit societies/ farmers service co-operative societies and the Pondicherry Co-operative Central Land Development Bank and outstanding as on 31.3.2006 and not waived under the Debt Waiver and Debt Relief Scheme, 2008 of the Government of India.

II. DEFINITIONS FOR THE PURPOSE OF THIS SCHEME:

a) “Agricultural co-operative credit institutions” means the Pondicherry State Co-operative Bank, primary agriculture co-operative banks/ primary agriculture co-operative credit societies/ village co-operative agriculture credit societies/ farmers service co-operative societies and the Pondicherry Co-operative Central Land Development Bank functioning in the Union territory of Puducherry;

b) “Implementing Agency” means all the agricultural co-operative credit institutions.

c) “Nodal Agency” means the Pondicherry State Co-operative Bank and the Pondicherry Co-operative Central Land Development Bank.

III. RELIEF:

(a) The amount of loan along with accrued interest outstanding as on 31.3.2006 availed for agricultural and its allied activities by the members of the agricultural co-operative credit institutions and not waived under the Government of India’s Debt Waiver and Debt Relief Scheme 2008 shall be waived.

Credit

(b) The penal interest and other charges outstanding in respect of the aforesaid loans shall also be waived.

(c) The amount of loan and interest repaid by the farmers from 1.4.2006 to 31.7.2006 out of loans outstanding up to 31.3.2006 shall be reimbursed to the members concerned or adjusted towards their subsequent loan account, if any.

IV. ELIGIBILITY CRITERIA TO AVAIL THE RELIEF:

- (a) The beneficiary under the scheme shall be a farmer and member of the agricultural co-operative credit institutions.
- (b) All types of loans such as short term, medium term and long term and short term, medium term and long term conversion loans availed by the farmer for agriculture and its allied activities which are not waived under Government of India's Debt Waiver and Debt Relief Scheme, 2008 are covered under this Scheme.
- (c) The loans include the balance of the principal, interest, penal interest and other charges of genuine cases and the loans issued on the bonafide documents and not claimed under Government of India's Debt Waiver and Debt Relief Scheme, 2008 shall be eligible for coverage of waiver under this Scheme.
- (d) If the loan is availed under various Government Schemes, the net amount after deducting the subsidy received from the Government up to the operation of the scheme only shall be waived.
- (e) The Pondicherry State Co-operative Bank and the Pondicherry Co-operative Central Land Development Bank are issuing non – farm sector loans such as loans for purchase of vehicles, brick making, construction of buildings for residential as well as commercial purposes, business expansion, etc., by pledging of documents. As these kinds of loans are not related to agricultural operations, they shall not be considered for waiver under this scheme.

V. FUND:

- (a) The overall requirement of the funds for the operation of this scheme will be met from the amounts sanctioned by the Government of Puducherry to the Pondicherry State Co-operative Bank / Pondicherry Co-operative Central Land Development Bank. The penal interest and other charges waived will not be eligible for reimburse and borne by the concerned agricultural co-operative credit institutions.

Credit

(b) For this purpose, a corpus fund account shall be created by the Registrar of Co-operative Societies and kept with the Pondicherry State Co-operative Bank / Pondicherry Co-operative Central Land Development Bank for the implementation of this scheme and the amount received from the Government shall be credited into this account. All the claims under this scheme will be met by the Registrar of Co-operative Societies from the corpus fund. On winding up of the scheme, the Pondicherry State Co-operative Bank / Pondicherry Co-operative Central Land Development Bank shall refund the balance amount outstanding in the corpus fund to the Registrar of Co-operative Societies.

VI. Method of Accounting:

(a) The loan amount (along with applicable interest as on 31.03.2006) outstanding as on 31.3.2006 and not waived under Government of India's Debt Waiver and Debt Relief Scheme 2008, in respect of each individual loanee should be "blocked" and shown as "Due from the Government" by crediting the member's loan account. The penal interest and other charges outstanding in the said members account as on 31.3.2006 and interest charged on the said loans from 1.4.2006 should be taken to "loss account" under a head "Loss on waiver of interest, penal interest and other charges".

(b) The Pondicherry State Co-operative Bank shall not collect periodical interest, penal interest and other charges from the primary banks/societies as well as from its members and the primary agriculture co-operative banks/ primary agriculture co-operative credit societies/ village co-operative agriculture credit societies/ farmers service co-operative societies and the Pondicherry Co-operative Central Land Development Bank shall not collect interest from the members of the societies concerned in respect of the 'blocked amount' from 1.4.2006.

(c) The amount shall be released by the Government of Puducherry on the blocked amount to the Pondicherry State Co-operative Bank (which includes the loans waived at the level of the primary agriculture co-operative banks/ primary agriculture co-operative credit societies/ village co-operative agriculture credit societies/farmers service co-operative societies) and the Pondicherry Co-operative Central Land Development

Credit

Bank. The Pondicherry State Co-operative Bank in turn shall release the amount to the concerned primary agriculture co-operative credit institutions. On receipt of the said amount from the Pondicherry State Co-operative Bank, the primary agriculture co-operative credit institutions shall credit the amount shown as “Due from the Government” and in turn discharge their liability to the Pondicherry State Co-operative Bank to the extent. The Pondicherry State Co-operative Bank shall in turn repay the farm sector loan dues to the NABARD, if any.

(d) The amount released by the Government of Puducherry on the blocked amount to the Pondicherry Co-operative Central Land Development Bank shall be credited to the amount shown as “Due from the Government” and the said bank shall in turn repay the farm sector loan dues to the NABARD, if any.

VII. Checking of the Blocked Loan Amounts

(a) Short Term and Medium Term loans including Medium Term and Long Term conversion loans

i) The agricultural co-operative credit institution concerned shall prepare a list of its members loans outstanding as on 31.3.2006 without any omission as per the Proforma – I. While preparing the list, the loans found to be issued without proper supporting documents, etc., shall be deleted. The list so prepared shall be countersigned by the President/Administrator/Special Officer of the society and it shall be sent to the Pondicherry State Co-operative Bank along with the board resolution, with a certificate as to the correctness of the claim.

ii) The Pondicherry State Co-operative Bank shall arrange to verify the particulars furnished in the list with the documents available in the society through the circle supervisor of the bank and a certificate to this effect has to be obtained from the circle supervisor as to the genuineness of the claims submitted by the society concerned.

iii) In the case of crop and farm sector loans issued directly by the Pondicherry State Co-operative Bank through its branches, the branch manager concerned shall prepare the said list and submit the same to their Assistant General Manager, with a certificate as to the correctness of the claims.

Credit

iv) The Pondicherry State Co-operative Bank shall verify the claims and consolidate them as per the Proforma - II and submit a proposal to the Registrar of Co-operative Societies so as to enable the release of the required amounts from the corpus fund maintained by Pondicherry State Co-operative Bank.

v) The claims so received from the Pondicherry State Co-operative Bank shall be scrutinized by a committee appointed by the Registrar.

(b) Long term loans:

- i) The Pondicherry Co-operative Central Land Development Bank shall prepare a list of its members loans outstanding without any omission after deleting the loans issued without proper supporting documents, etc., as per the Proforma- I.
- ii) The said list shall be signed by the manager concerned as to its correctness and countersigned by the Managing Director of the Pondicherry Co-operative Central Land Development Bank, Puducherry.
- iii) The bank shall pass a resolution for the waiver of the consolidated amount of loans outstanding so arrived in the above said list and submit a proposal to the Registrar in this regard so as to enable the to release of the required amounts from the corpus fund maintained by the Pondicherry Co-operative Central Land Development Bank.
- iv) The Registrar shall constitute a committee to verify the claims as regards the genuineness thereof.

VIII. Other conditions:

- (a) The loan amounts repaid by the farmers either directly or recovered from the sugar mills from 1.4.2006 to 31.7.2006 in respect of loans outstanding as on 31.3.2006 covered under the scheme shall be refunded fully to the farmers concerned after the release of funds by the Government of Puducherry or shall be adjusted towards the repayments of the subsequent loans availed by them in the concerned agricultural co-operative credit institution.

Credit

- (b) The subsidy portion released under the Government Schemes shall be deducted on the outstanding loan amounts and the net amount only shall be waived.
- (c) A certificate with regard to the waiver of loan amounts along with the details and 'no due certificate' shall be issued to all the farmers on or before 2.10.2008.
- (d) The documents mortgaged for the loans obtained by the farmers covered under this scheme shall be released to the farmers concerned along with the certificate mentioned above.
- (e) Since the loans have been waived by the Government of Puducherry the agricultural co-operative credit institutions should not initiate any action for collection of these loans.
- (f) The proceedings if any initiated by the societies for recovery of these loans under the Pondicherry Co-operative Societies Act, 1972 shall be withdrawn immediately.
- (g) The farmers who get waiver under this scheme shall be eligible to obtain fresh loans.
- (h) The societies shall initiate appropriate timely action for recovery of new loans issued to the farmers along with interest.
- (i) It should be ensured that the benefits under this scheme are not extended to institutions / firms, etc.
- (j) It shall be ensured that the waiver of the loans is recorded in the books of account of the societies and adjusted towards the loan account of the farmers.
- (k) The societies shall intimate the fact of waiver of loans, interest etc., clearly to the farmers concerned individually.
- (l) The waiver of co-operative loans shall be advertised in such a way that the public shall know the amount of loan waived and the number of beneficiaries etc., by

Credit

displaying posters in important places in the area of operation of the society concerned and the details of the loans availed by the farmers and amount waived may be displayed in the notice board of the agricultural co-operative credit institutions.

IX Grievance Redressal

Any farmer who is aggrieved on the ground that his name has not been included in the list and the relief granted to him has been calculated wrongly may make a representation to the Managing Director, Pondicherry State Co-operative Bank / Pondicherry Co-operative Central Land Development Bank as the case may be. Every such representation shall be disposed of within 30 days of receipt thereof.

X Interpretation and power to remove difficulties.

If any doubt arises on the interpretation of any paragraph of this scheme or any instructions issued thereunder the Secretary (Co-operation), Government of Puducherry shall resolve the doubt and the decision of the Secretary (Co-operation) shall be final.

If any difficulty arises in giving effect to the provisions of the scheme or any instructions issued thereunder, the Government of Puducherry may by order do anything which appears to it to be necessary or expedient for the purposes of removing the difficulty.

The Lieutenant Governor has been pleased to make the rules / guidelines for the establishment and operation of the scheme relating to reimbursement of tractor hire charges to the members of the primary agricultural co-operative banks / primary agricultural co-operative credit societies/village co-operative agricultural credit societies and farmers service co-operative societies registered under the Pondicherry Co-operative Societies Act, 1972 (Act No. 7 of 1973) as mentioned in the annexure to this Government Order so as to subsidize the cost of cultivation of the farmers who are members of the agricultural co-operative credit society.

2. This issued with the concurrence of the Finance Department vide their U.O. No.30644/FD/F5/A2 dated 16/17.4.2009.

ANNEXURE

Rules for “Reimbursement of Tractor Hire Charges” to the members of the Primary Agricultural Credit Co-operatives.

*

1. Short title and commencement

(a) These rules shall be called as the Rules for Reimbursement of Tractor Hire Charges to the Members of the Primary Agricultural Credit Co-operatives, 2009.

(b) These rules shall come into force with immediate effect.

2. Aims and Objects: The main aim of the scheme is to subsidize the cost of cultivation of the farmers who are members of the agricultural co-operative credit societies/banks/farmers service co-operative societies which are registered under the Pondicherry Co-operative Societies Act, 1972 (Act No.7 of 1973) by providing them tractor and other agricultural implements at reduced hire charges.

3. Definitions:- In these rules, unless the context otherwise requires,-

- (a) “Apex Society” means the Pondicherry State Co-operative Bank Limited;
- (b) “Implementation Agency” means the Co-operative Department, Government of Puducherry;
- (c) “Nodal agency” means the Pondicherry State Co-operative Bank Limited;
- (d) “Primary Agricultural Credit Co-operatives” means primary agricultural co-operative banks/primary agricultural co-operative credit societies/farmers service co-operative societies and village co-operative agricultural credit societies which are registered under the law for the time being in force;
- (e) “ Member” means any person holding at least one “A” class share in the society referred in clause (d);
- (f) “Small Farmer” means a farmer engaged in cultivating agricultural land (as owner or tenant or share cropper) holding agricultural land up to 2 hectares (5 acres); and
- (g) “Scheduled Case Farmers” means any person who belongs to scheduled caste community and engaged in cultivating agricultural land.

4. Operational guidelines of the Scheme:-

- (i) *Implementing agency:-* The Co-operative Department of the Government of Puducherry shall be the implementing agency for the reimbursement of tractor(s) hire charges in respect of the tractor services availed by the small farmers and the scheduled caste farmers who are members of the primary agricultural credit co-operatives.
- (ii) *Nodal Agency:-* The apex society shall act as the “Nodal Agency” for checking and certifying the claims and sending the claims to the Co-operative Department for release of funds.
- (iii) *Funds:-* Sufficient funds will be provided for implementation of the said scheme in the budget estimate by the Co-operative Department.
- (iv) *Eligibility to avail the Subsidy:-* The beneficiary shall be a member of the primary agricultural credit co-operatives who has availed services of the tractor and such member shall be either a small farmer or scheduled caste farmer.
- (v) *Procedure of claim:-*
 - (a) The member shall submit an application for booking of society's tractor/ agricultural implements on hire basis as prescribed in Annexure – I. After satisfying himself that the particulars furnished by the member are correct, the President / Manager of the society shall authorize the movement of the tractor / agricultural implement.
 - (b) The society shall maintain a registrar for movement of society's tractor/other agricultural implements on hire basis as prescribed in the Annexure – II.
 - (c) The small farmer(s) has to pay 1/2 of the tractor hire charges for availing the services from the primary agricultural credit co-operatives as prescribed by the Registrar of Co-operative Societies from to time.
 - (d) The scheduled caste farmer(s) has to pay 1/3 of the tractor hire charges for availing the services from the primary agricultural credit co-operatives as prescribed by the Registrar of Co-operative Societies from to time.
- (vi) *Claims:-* The agricultural co-operative credit societies shall furnish the particulars of eligible members, tractor hire charges paid by them and the amount of re-imburement claimed at the end of every year as on 31st of March in the Form No. I and Form No. II to the Nodal Agency and on receipt of the claim the Nodal Agency shall scrutinize, verify and certify as to the correctness of the claim and forward the same to the Co-operative Department.

Credit

The implementing agency on receipt of the claims from the nodal agency shall sanction the claim to the societies concerned.

- (vii) *Removal of difficulty in the implementation of the Scheme:-* If any doubt or difficulty arises in the course of the implementation of the Scheme, the matter will be referred to the Secretary to Government (Co-operation), whose decision shall be final.
