S.O. 1127(E) – In exercise of powers conferred by Section 15 of the Handlooms (Reservation of Articles for Production) Act, 1985, (22 of 1985) and in supersession of the notifications of the Ministry of Textiles (Department of Textiles), (Office of the Development Commissioner for Handlooms) No.S.O. 89 (E) published in the Gazette of India, Extraordinary Part II, Section 3, Sub Section (ii) dated 12th February, 1987 and No. S.O. No.61 (E) dated 19th January, 1994 except in respect of things done or omitted to be done before such supersession, the Central Government hereby directs that the powers exercisable by it under the provisions of the said Act as specified in the column (3) of the table below shall be exercisable also by the officers or authority as specified in column (2) of the table, namely:-

**DIRECTIONS OF THE REGISTRAR OF COOPERATIVE SOCIETIES ISSUED
UNDER SECTION 81 OF THE PUDUCHERRY CO-OPERATIVE
SOCIETIES ACT, 1972**

Sub: Admission of individual members in Primary Weavers
Co-operative Societies - Procedure to be followed by
Committee of Management - Direction under Section 81 of
the Puducherry Co-operative Societies Act, 1972 - Issued.

ORDER

WHEREAS it is brought to the notice of the undersigned that the primary weavers co-operative societies functioning in the Union territory of Puducherry are admitting as members, those who have no knowledge of weaving or allied activities and thereby the society's funds are not utilized properly;

AND WHEREAS, the Co-operative Department vide direction issued under Section 81 of the Puducherry Cooperative Societies Act, 1972, No. RCS/CLC/CIR/2003/4 dated 22.1.2003 directed all the cooperative societies working in the Union territory of Puducherry prescribed the guidelines for admission of individuals as members of the co-operative societies;

AND WHEREAS, the primary weavers co-operative societies are also bound by the said direction;

AND WHEREAS, it is felt necessary to prescribe the following procedures/guidelines in addition to the direction dated 22.1.2003 stated in the pre-paras for compliance by the primary weavers co-operative societies:

- (a) The application received for admission as a member of the primary weavers co-operative societies should be scrutinized by the committee of management and ensured that the person who has applied for membership does not attract any disqualifications mentioned in the Puducherry Co-operative Societies

Act, 1972 and the Puducherry Co-operative Societies Rules, 1973 or the bye-laws of the society.

- (b) The committee of management should ensure that no amount is collected in the form of share capital/share suspense from the individual who applied for membership at this stage.
- (c) After scrutiny of the application of the individual and if he is found to be otherwise eligible to be admitted as a member under the Act, Rule and bye-laws. The committee of management should take action to obtain a certificate from the technical supervisors working in the Co-operative Department, Puducherry or the technical supervisors of the PONTEX that the individual knows weaving/allied works related to weaving.
- (d) The committee of management after obtaining the certificate from the said technical supervisors and satisfying itself that the individual knows weaving/allied works as the case may be, admit the individual concerned as a member of the society after collecting the share capital and the entrance fees amount, allotting the share after passing a resolution.

NOW THEREFORE, with a view to secure proper management of the primary weavers co-operative societies and to ensure that only real weavers are admitted as members of the primary weavers co-operative societies and get all benefits, in exercise of the powers conferred by section 81 of the Puducherry Co-operative Societies Act, 1972, I hereby direct the committee of management to strictly follow the above said guidelines in the matter of admission of individuals as the members of the primary weavers co-operative societies.

The receipt of the direction should be acknowledged.
